How much does a solar panel subsidy cost?

Under the solar panel govt subsidy, residential consumers receive INR30,000 per kW up to 2 kW and INR18,000 per kW for additional capacity up to 3 kW, with the total subsidy capped at INR78,000 for rooftop systems of 3 kW or more.
