What is the tariff rate for imports from Namibia?

The current tariff rate for imports from Namibia is 15%. However, this rate can vary depending on the specific product category and any applicable trade agreements or exceptions. How are excise duties harmonised in Namibia?

Namibia's regimes on excise duties are harmonized within SACU. Excise duties are either specific or ad valorem, and are applied at the same rate on imported and domestically produced goods.
